

- To implement Development Sector Projects with strong focus on Water, Sanitation & Hygiene, Nutrition and Disaster Risk Reduction in communities and Institutions
- To support organizations in developing professional cadre of rural facilitators
- To provide desk and field surveys, research, evaluations and consultancy support.
- To pilot and demonstrate replicable strategies, processes and actions which can contribute to empower communities.

Organizational Experience

WADS brings a diverse set of experience team of professionals from different sectors. Though the organisation has been formed recently, the team of directors have more than 44 years of experience in the development sector jointly. Both the Directors and the Executive Director have worked with government departments and with national and international agencies (like UNICEF, World Bank, DFID etc.) for long period of time. They have facilitated large scale implementation projects on water, sanitation, disaster risk reduction, waste management, climate change, water conservation etc. They have designed several evaluations and survey works and facilitated report preparations on the evaluations done. WADS has an experienced training team that brings field level experience along with theoretical concepts in different training activities. Presently some of the activities of the ongoing activities of the organisation are:

- Working with UNICEF Bihar and Lohiya Swachh Bihar Abhiyan (LSBA) on "Promotion of Safely Managed Sanitation Systems and (SMSS) and Hand Hygiene for All (HH4A)" in Araria district of Bihar along with Training support to the Patna Municipal Corporation and ULBs of Bihar on SLWM, GFC, Safety & Security of Sanitation workers and Swachh Survekshan 2023
- Working with Lohiya Swachh Bihar Abhiyan (LSBA) on Solid and Liquid Waste Management (SLWM) in rural areas of Bihar
- Working with GIZ in 4 wards of Patna Municipal Corporation for Promoting Source Segregation Awareness, Adoption of HH Composting Practices, Strengthening of MRF facility and Enhancing the Capacities of Stakeholders in Patna, Bihar Under The "Waste Solutions for A Circular Economy in India"

- Under the aegis of Patna Municipal Corporation (PMC), UNFPA and Diksha Foundation, WADS has facilitated the 19 batches of Training (four days) of all staffs (Zonal Incharges, Sanitary Inspectors and Sanitation Supervisors) on Sanitation, Swachh Survekshan, City planning etc.

 the training of SHG women on Toilet Cleaning and developed them as Sanitation
 Janitors thus engaging them for a sustainable livelihood option and toilet functionality
 in the Patna city.
- Development of Standard Operation Procedures (SOPs) for staff deployed and other works/activities of Patna Municipal Corporation (PMC). This included
 - SOP for Chief Sanitary Inspector
 - SOP for Zonal Incharge
 - SOP for Sanitation Inspector (SI)
 - SOP for Sanitation Supervisors
 - SOP for City Fogging
 - SOP for Street Sweeping
 - SOP for Street Lighting
- Development of **Patna Survekshan Application and Dashboard** along with the training of teams to facilitate evaluation of PMC activities in all the Circles (6) and all 75 Ward on four different parameters.
- Development of **IEC materials for Patna Municipal Corporation** (PMC)

Experience of the Directors

1. Shashi Bhushan Pandey

with evaluation studies across the country. His video documentation of toilet construction has been displayed across the country and widely used as a training material in Swachh Bharat Mission (SBM-G).

2. Indraneel Ghosh

Mr. Indraneel Ghosh has been in the development sector for more than 23 years and has worked with various national and international organisations and government departments in the states of Bihar, Jharkhand, Rajasthan, Chhattisgarh and Madhya Pradesh. He has implemented several large scale projects on WASH in these states. Along with the implementation he has the experience of project planning, facilitate evaluation studies, documentation, MIS development, facilitate trainings and capacity building of various stakeholders. He has also been involved with the Bihar government in developing the strategy on sanitation, water supply, climate change and solid and liquid waste management in the state. He has been in the sector since the launch of Sector Reforms in the country and has significant experience in planning and implementation of sanitation & water supply based schemes, Swajaldhara and NRDWP. He has also been involved in developing several knowledge management products for the government and other national and international organisations also. He has been extensively supporting the Rural Development Department (RDD), Public Health Engineering Department (PHED), Bihar, Patna Municipal Corporation, Lohiya Swachh Bihar Abhiyan (LSBA), District Water and Sanitation Committees in the implementation of Swachh Bharat Mission (SBM) during the first phase and also during the second phase focusing on ODF sustainability and ODF Plus activities (SWM & LWM), disaster management and monitoring & evaluation activities.


Organization Expertise
